# 1) Question:

Will Food Service Consultant services be contracted directly by the New Milford Board of Education, or are they to be provided through the awarded A&E firm?

#### Answer:

Food Service Consultant services are to be provided through the awarded A&E firm. All costs associated with such consultations are to be included in the firm's lump-sum bid and incorporated as part of the overall scope of work.

### 2) Question:

Is the proposed room constructed as slab-on-grade?

#### Answer:

Based on available information and site observations, the room is understood to be slab-on-grade. Bidders should reference their site visit observations when preparing their proposals.

## 3) Question:

Is the roof above the classroom flat, and what is the nature of the space above the ceiling?

#### Answer:

Based on available information and site observations, the roof above the classroom is understood to be flat. The space above the ceiling grid is estimated to be approximately 4 feet, with trusses approximately 24 inches in height, and contains various mechanical systems. Bidders should reference their site visit observations when preparing their proposals.

# 4) Question:

What type of HVAC equipment currently supplies the space?

### Answer:


Based on available information and site observations, the space is served by an air handler providing both heating and cooling, in conjunction with dedicated Variable Air Volume (VAV) units for that room. Bidders should reference their site visit observations when preparing their proposals.


### 5) Question:







FIRST FLOOR PLAN - PART "D" **FIRE PROTECTION** 







FIRST FLOOR PLAN - PART "D" - HVAC






